- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Promoting Good Cyber
- 5 Hygiene Act of 2017".
- 6 SEC. 2. CYBER HYGIENE BEST PRACTICES.
- 7 (a) Establishment.—Not later than 1 year after
- 8 the date of enactment of this Act, the National Institute

of Standards and Technology, in consultation with the Federal Trade Commission and the Department of Homeland Security, after notice and an opportunity for public comment, shall establish a list of best practices for effec-4 5 tive and usable cyber hygiene for use by the Federal Government, the private sector, and any individual or organi-6 7 zation utilizing an information system or device. Such list 8 shall— 9 (1) be a list of simple, basic controls that have 10 the most impact in defending against common 11 cybersecurity threats and risks; 12 (2) utilize technologies that are commercial off-13 the-shelf and based on international standards; and 14 (3) to the degree practicable, be based on and 15 consistent with the Cybersecurity Framework con-16 tained in Executive Order 13636, entitled Improving 17 Critical Infrastructure Cybersecurity, issued in Feb-18 ruary 2013, or any successor framework. 19 (b) Voluntary Practices.—The best practices on the list established under this section shall be considered 20 21 voluntary and are not intended to be construed as a list 22 of mandatory actions. 23 (c) Baseline.—The best practices on the list established under this section are intended as a baseline for the Federal Government, the private sector, and any indi-

- 1 vidual or organization utilizing an information system or
- 2 device. Such entities are encouraged to use and improve
- 3 on those best practices.
- 4 (d) UPDATES.—The National Institute of Standards
- 5 and Technology shall review and update the list of best
- 6 practices established under this section on an annual

- 8 (e) Public Availability.—The list of best practices
- 9 established under this section shall be published in a clear
- 10 and concise format and made available prominently on the
- 11 public websites of the Federal Trade Commission and the
- 12 Small Business Administration.

- 14 MENTS.—Nothing in this section shall be construed to su-

5	subsection, the term "Internet of Things" means the

8	(2) Study required.—The Secretary of
9	Homeland Security, in coordination with the Direc-
10	tor of the National Institute of Standards and Tech-
11	nology and the Federal Trade Commission, shall
12	conduct a study on cybersecurity threats relating to
13	the Internet of Things.
14	(3) Matters studied.—As part of the study
15	required by paragraph (2), the Secretary shall—
16	(A) assess cybersecurity threats relating to
17	the Internet of Things;
18	(B) assess the effect such threats may
19	have on the cybersecurity of the information
20	systems and networks of the Federal Govern-
21	ment (except for the information systems and
22	networks of the Department of Defense and the
23	intelligence community (as defined in Section 3
