## **DEFENDANT'S STATUS REPORT**

Pursuant to this Court's order, dated December 2, 2025, the United States hereby submits the following status report. As noted in our prior status reports, the National Institutes of Health Information Technology Acquisition and Assessment Center (NITAAC), within the U.S. Department of Health and Human Services (HHS), has been evaluating the impact of Executive Order 14240 - *Eliminating Waste and Saving Taxpayer Dollars by Consolidating Procurement* to determine what impact, if any, this order will have on the final evaluation and the procurement at issue in this protest. NITAAC has been coordinating its efforts with other Executive branch components in this effort. During this time, NITAAC has also conducted an evaluation of the program's needs.

As a result of these efforts, HHS has shifted its focus away from re-evaluation of existing offers, which was the focus of the remand because it anticipates canceling the Chief Information Officer – Solutions and Partners (CIO-SP4) solicitation #75N98121R00001NIHin its entirety. The agency anticipates that it will complete this process within the next thirty days. The agency further anticipates that the bridge contracts on the current CIO-SP3 contracts will be extended for a period of one year. The United States will update the Court and the parties when this process is completed.
