This iteration does not include an accompanying detailed methodology file. Methodologies for incremental, dashboard, PortfolioStat, and MGT components remain unchanged. The following components have notable changes: Closures – Agencies with B grades have closures beyond 2023 and did not clarify the reason in their response letter. FISMA - Includes the adjusted IG assessment (FY2022) and Federal Cybersecurity Progress Report scores (FY2023 Q2). EIS - Pass/fail based on 95% or above disconnects as of August 31, 2023. Data sources remain largely the same as Scorecard 15 with the addition of agency response letters. IT Dashboard data are as of September 20, 2023. DOD data are mostly as of December 2022 except information provided on the IT Dashboard related to data center closures beyond FY2023. Preview ratings are based on completeness of response letters; "Pending" indicates forthcoming responses.
